

SERVICE AGREEMENT

National Centre for Management & Training (NCMT), having its principal office at Musaffah M-39, hereinafter referred to as "NCMT," and
Al Roumi General Trading, H2S Safety Division, having its principal office at Musaffah hereinafter referred to as "Al Roumi."

Whereas:

1. NCMT requires the provision of equipment and services to support its operations, including but not limited to Emergency Breathing Apparatus (EBA) hood type and EBA Mask type
2. Al Roumi has the expertise and resources to supply the necessary equipment and perform associated services, including checks, cleaning, disinfection and maintenance, and calibration, in adherence to Manufacturer recommendations.
3. Al Roumi has the Resource (BA Compressor) to Refill EBAs Mask & Hood
4. Al Roumi will supply EBA masks & Hoods on rental basis as require by NCMT

Now, therefore, the parties agree as follows:

1. Scope of Agreement

- 1.1 Al Roumi shall supply NCMT with necessary equipment, including EBA Hood & Mask and other related items as requested.
- 1.2 Al Roumi shall perform the necessary checks, cleaning, disinfection, refilling and maintenance as per Manufacturer Recommendation
- 1.3 Al Roumi shall provide calibration inspection report upon completion of the required services.
- 1.4 Al roumi will conduct the Breathing Air Quality check as per BS EN 12021 standard in a frequency of 3 months.

2. Quality Standards

- 2.1 Al Roumi shall adhere to the utmost quality standards as per the applicable industry regulations, manufacturer recommendations and best practices.
- 2.2 All equipment supplied, and services rendered by Al Roumi shall be of high quality, reliable, and compliant with international safety standards.

3. Responsibilities of NCMT

- 3.1 NCMT shall provide Al Roumi with timely access to the equipment requiring service.
- 3.2 NCMT shall ensure timely communication regarding the specific equipment and service requirements.



4. Term and Termination

4.1 This Agreement shall commence on 05.05.2025 specified above and shall remain in effect until terminated by either party with a 30-day written notice.

4.2 In the event of non-compliance by either party with the terms of this Agreement, the other party may terminate this Agreement with immediate effect upon written notice.

5. Payment Terms

5.1 NCMT shall compensate Al Roumi for the services rendered and equipment provided in accordance with the agreed-upon rates, which shall be detailed in a separate schedule or purchase order.

5.2 Payments shall be made against the receipt of an invoice from Al Roumi.

6. Confidentiality

6.1 Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the term of this Agreement.

7. Governing Law

7.1 This Agreement shall be governed by and construed in accordance with the laws of Abu Dhabi.

8. Entire Agreement

8.1 This Agreement constitutes the entire understanding between NCMT and Al Roumi concerning the subject matter herein and supersedes all prior agreements, negotiations, and discussions.
